No other person shall so operate unless licensed by the registrar unless he possesses a receipt issued under section eight for persons licensed in another state or country or unless he possesses a valid learners permit issued under section eight B, except

as is otherwise herein provided or unless he is the spouse of a member of the armed forces of the United States who is accompanying such member on military or naval assignment to this commonwealth and who has a valid operators license issued by another state, or unless he is on active duty in the armed forces of the United States and has in his possession a license to operate motor vehicles issued by the state where he is domiciled, or unless he is a member of the armed forces of the United States returning from active duty outside the United States, and has in his possession a license to operate motor vehicles issued by said armed forces in a foreign country, but in such case for a period of not more than fortyfive days after his return. The motor vehicle of a nonresident may be operated on the ways of the commonwealth in accordance with section three by its owner or by any nonresident operator without a license from the registrar if the nonresident operator is duly licensed under the laws of the state or country where such vehicle is registered and has such license on his person or in the vehicle in some easily accessible place.

Subject to the provisions of section three, a nonresident who holds a license under the laws of the state or country in which he resides may operate any motor vehicle of a type which he is licensed to operate under said license, duly registered in this commonwealth or in any state or country; provided, that he has the license on his person or in the vehicle in some easily accessible place, and that, as finally determined by the registrar, his state or country prescribes and enforces standards of fitness for operations of motor vehicles substantially as high as those prescribed and enforced by this commonwealth. The nonresident shall have in their possession a valid international drivers permit, or a document containing a photo and an English translation that substantially corresponds to an international driving permit, that shall be used solely to properly identify the individual appearing on the license for the purpose of enforcing this section if no English translation appears on the front or back of the license that the nonresident is required to have in possession at all times while operating a motor vehicle. Operation of a motor vehicle in violation of this paragraph shall be subject to the same penalties as provided in section twentythree for operation after suspension or revocation and before restoration or issuance of a new license or the restoration of the right to operate. In New Hampshire and Tennessee, the Division of Motor Vehicles and the Driver License Services Division, respectively, is a division of each states Department of Safety in Tennessee, Department of Safety and Homeland Security. In Vermont, the Department of Motor Vehicles is a subunit of the state Agency of Transportation. For example, in the state of Washington, the Department of Licensing is responsible for drivers licenses and vehicle and boat registrations in addition to most other business and occupational licensing. In Maine, Michigan, and Illinois, the Secretary of States offices perform responsibilities that would be handled by the DMV in other states.

These individuals have the option of retaining the license and vehicle registration of their legal residence or obtaining a new license and registration locally. However, federal employees authorized to drive such vehicles must still be licensed by their home state or territory. The REAL ID Act of 2005 is an attempt to provide a national standard for identification cards in the United States as identification cards are commonly used in everyday life. All DMVs issue their states Drivers manual, which all drivers are expected to know and abide by. Knowledge of the drivers manual is tested prior to issuing a permit or license. A vehicle registration program tracks detailed vehicle information, such as odometer history, to prevent automobilerelated crimes such as odometer fraud. The types of vehicles certified by a DMV varies by state. While almost all DMVs title vehicles that are driven on roadways, the responsibility to title boats, mobile homes, and offroad vehicles can be the responsibility of other agencies such as a Department of Natural Resources DNR. Inspectors also investigate independent inspection stations licensed by the DMV. At times, some of these stations violate DMV regulations codified by law. The most common of these violations is passing inspection for a vehicle with windows tinted below the legal limits. It employs investigators to combat auto theft, identity theft, and fraudulent documentrelated crimes that take place in New York. These investigators are armed New York State peace officers with statewide authority to enforce laws and handle investigations.
